TRADEOFFS' PODCAST, ARTICLES, NEWSLETTER AND EVENTS REACH MORE THAN 170,000 PEOPLE EACH MONTH, INFLUENCING POLICYMAKERS, EDUCATORS, JOURNALISTS AND THE PUBLIC ALIKE. IN 2024, OUR WORK CONTINUED TO ELEVATE THE NATIONAL DISCOURSE AROUND HEALTH POLICY. OUR MODEL OF ACCESSIBLE REPORTING THAT PAIRS DATA AND EVIDENCE WITH THE STORIES OF REAL PEOPLE DEEPLY RESONATED WITH OUR AUDIENCE. IN OUR 2024 AUDIENCE SURVEY, 96% OF RESPONDENTS REPORTED THEY USE TRADEOFFS TO INFORM THEIR THINKING ABOUT HEALTH CARE.
